Outcomes of C&M AMR Board Meeting (25th July 2018)

Key actions agreed at the meeting

- Geographical areas for AMR lead consultant microbiologists confirmed:

- Agreed to have one antimicrobial formulary / guidance for each one of the three Place Based Care Systems.
- Agreed to work towards establishing a functioning AMR working Group in each one of the three Place Based Care Systems.

Key findings - most hot spots of antibiotic prescribing appear in the North of England (Merseyside is one of the hotspot areas for antibiotic prescribing); hot spot areas for antibiotic prescribing are more socio-economically deprived; and area level strategies for antimicrobial stewardship are recommended.
